

## TERMS AND CONDITIONS UNIVERSITY OF BERN SUMMER SCHOOL

### 1. Application

- 1.1. Students apply using the online application form. Only on time (in accordance with published deadlines), full applications including all required documents will be considered for admission.
- 1.2. By completing the online application form students accept the general terms and conditions of the University of Bern Summer School.
- 1.3. Students allow the University of Bern to save their personal data and to use it for the summer school organization, for statistical purposes and to send the student information about the program.
- 1.4. Individual courses have their own entry requirements, which are defined in the course descriptions on the website of the Summer School. The student is expected to be familiar with the entry requirements.
- 1.5. Students are expected to have at least a B2 level of English, as developed within the [Common European Framework of References for Languages \(CEFR\)](#). This is comparable to a Toefl internet test with a score of 92, or an IELTS score of 6.5.
- 1.6. It is the students' responsibility to determine whether they meet the English language level that is needed to successfully complete the courses. Students do not need to provide language tests to the University of Bern Summer School.
- 1.7. The University of Bern Summer School does not accept liability for any inconvenience or failure to attend due to the participant's lack of English language proficiency.

### 2. Admission Requirements

- 2.1. University of Bern Summer Schools courses are selective and places are restricted.
- 2.2. Course applications are evaluated by the University of Bern Summer Schools Team and/or Faculty, who reserve the right to deny access to a course if the candidate does not satisfy the admission requirements.
- 2.3. In case there are more applicants than places, students might be rejected even though they meet all formal requirements.
- 2.4. It is only upon reception of the full tuition payment that an applicant is considered formally enrolled and their place in the course is secured.

### 3. Tuition Fees and Payment

- 3.1. Tuition fees are as advertised on the website and can only be paid in Swiss Francs (CHF).

- 3.2. Once students have been accepted for a course, they receive by e-mail all necessary information for payment.
- 3.3. Tuition fees must be paid within the time frame determined by the course director and communicated in the Admissions Email. If payment is not made in due time, University of Bern Summer Schools reserves the right to cancel the admission and attribute the place to another candidate.

## 4. Cancellation policy

### Cancellation by the University of Bern Summer School

- 4.1. The University of Bern Summer School reserves the right to cancel the course, for example due to lack of interest. Applicants will be informed of a cancellation as soon as possible. Students should keep this in mind when making travel arrangements; any expenses made other than course fees, will not be reimbursed.
- 4.2. If in the opinion of the University of Bern Summer School placement or admission is not possible, or if the course had been cancelled, the registration will be annulled without any costs and course fees already paid will be fully reimbursed.

### Cancellation by the participant

- 4.3. Costs will be owed in case of cancellation or if the participant interrupts the course or ends it prematurely. These costs are as follows:
- 4.4. Cancellations up **until 28 July 2019**: The University of Bern will refund the fee paid, less the sum of 100 Swiss francs to cover administration and banking fees.
- 4.5. Cancellations **after 28 July 2019**: There will be no refund.

## 5. Credits

- 5.1. Full time attendance and active participation in class is required of all students. Not meeting these requirements may result in failing a course or dismissal from the University of Bern Summer School.
- 5.2. Under no circumstances are academic dishonesty, plagiarism and cheating accepted. See [Guidelines of the University Board concerning the procedure for dealing with plagiarism.](#)
- 5.3. All courses will be concluded with an exam and students will be given a pass/fail or a grade for the course.
- 5.4. Students will receive a certificate of participation. The document will include information about the credit weight per course in European Credits (ECTS; one ECTS-credit symbolizes 25-30 study hours - both contact as well as self-study hours).
- 5.5. The students are responsible for making arrangements for the recognition of credits at their home university. Neither the University of Bern Summer School nor the University of Bern has any responsibility in this respect.

## **6. Housing**

- 6.1. Students have the possibility to rent a room directly from the [VBSL \(Verein Berner Studentenlogierhaus\)](#) at their own expense.
- 6.2. The VBSL is an independent organization and legal entity. Students, who want to rent a room have to accept their terms and conditions.
- 6.3. The University of Bern Summer School is not responsible for the quality of the housing or other problems regarding the accommodation. Any complaints should be made directly to the responsible housing corporation.
- 6.4. Students do not have to pay a deposit to the VBSL, because the University of Bern acts as surety. However, in case of costs for damage, insufficient cleaned rooms, etc. caused by a student, they have to cover these expenses up to an amount of 250 CHF.

## **7. Visa and Health Insurance**

- 7.1. Students are responsible for arranging their own entry visa, if applicable. If needed, students can request an admission statement for their visa application, but only after full payment is received by the University of Bern Summer School. Students should apply for a tourist visa (Schengen Visum) and not a study visa. The University of Bern Summer School urges all participants from outside the European Union to check which visa requirements may apply as early as possible with the Swiss Embassy or the Swiss Consulate.
- 7.2. Rejection of a visa application does not affect these terms and conditions, including the cancellation policy as described in clause 4.
- 7.3. Students carry responsibility for their own insurance. Please make sure your insurance covers health insurance, liabilities, and accidents that may occur during your stay in Switzerland. The University of Bern does not accept any responsibility for such risks as injury, illness, loss or damage to property, accidents, etc.

## **8. Code of conduct and liability**

- 8.1. Students are required to abide by all applicable rules and regulations of the University of Bern Summer School and University of Bern, all applicable rules and regulations of the specific housing company and by all applicable laws, rules, and regulations of Switzerland. In case of violation by the student, the University of Bern Summer School has the right to terminate the student's participation and to expel the relevant student. In case of expulsion no refund will be given to the individual.
- 8.2. University of Bern Summer Schools participants will not obtain the status of an official student at the University of Bern.
- 8.3. These general terms and conditions will supersede and override any different or additional terms or conditions in relation to the University of Bern Summer School, as for instance put forward by partner institutions.

- 8.4. Any disputes resulting from the agreement between the participant and the University of Bern Summer School that cannot be resolved in mutual consultation will be brought before the court in Bern.

## **9. Consent photography/video/written material**

- 9.1. The University of Bern uses photographic images and shots of International Summer School participants, and excerpts from feedback forms in marketing and publicity material. By accepting their place at the International Summer School, students are also giving consent for their words and photographic images to be used for this purpose.
